壹、申請資格/ Application Eligibility

一、入學身份/Identity

(一)、外國學生/ International Students

申請至本校就讀之外國學生，其應備文件及相關規定應以中華民國教育部網站公布之最新『外國學生來臺就學辦法』之規定為準，若有修改，以教育部為主。教育部相關資訊網址：<https://law.moj.gov.tw/LawClass/LawAll.aspx?PCode=H0110001> 及本校網站。

二、學歷要求/ Academic Qualification

申請國際專修部者需符合下列要求 Applicants for this program should meet the following requirements

(一)、具官方單位認證之國外高中畢業或以上學歷。

Officially recognized high school diploma or higher qualification.

(二)、具有與我國學制相當之同等學力資格者。

Applicants with equivalent qualifications to the academic degree system of Taiwan can apply for admission.

(三)、申請人畢業學校須為我國教育部認可或當地國政府權責機關或專業評鑑團體認可，符合教育部「大學辦理國外學歷採認辦法」規定之學校或我國政府立案之學校。

Applicants must have graduated from schools accredited by the Ministry of Education of the R.O.C. or recognized by local government agencies or professional evaluation organizations, per the 'Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education'.

二、住宿費 Accommodation Fee

(一)、本校備有男女生宿舍，每間房可住 4 人，設置有網路、電話、空調、電腦桌及單元式傢具等溫馨舒適。學生宿舍費用每學期新臺幣13,500元，寒暑假每週新臺幣612元。

The dormitory fee for 4-bed room is NTD\$13,500 per semester, and NTD\$612 per week during summer/winter break. All rooms are equipped with air conditioner, computer tables, simple furniture, and telephone, with free Wi-Fi.

(二)、凡申請住宿且已分配床位之學生，應繳交宿舍履約保證金 2,000 元，保證履行本校住宿住滿一學年為期之約定。已按規定住滿第一學期而同學年第二學期續住者，其宿舍履約保證金於同學年第二學期住宿繳費單中自動扣除。凡未住滿第一學期或住滿第一學期但同學年第二學期不續住者，其宿舍履約保證金一律不予退還。

Students are required to pay dormitory contract bond of NTD\$ 2,000 per person upon applying for dormitory accommodation, as a guarantee deposit for fulfilling a whole year dormitory residency agreement. For students who have completed the first semester and continue to stay in the dormitory for the second semester, the dormitory contract bond will be automatically deducted from the second semester's accommodation fee. For students who have not completed the first semester or have completed the first semester but do not continue to stay for the second semester, the dormitory contract bond will not be refunded.

柒、獎學金/ Scholarships

(一)、進入學士班課程後第一學年第二學期減免全額之學費及雜費。

Full tuition and miscellaneous fees will be waived for the second semester of the first academic year of the bachelor's program.

(二)、學士班第二至第四學年，前一學期班級排名達前百分之十者，減免全額之學費及雜費；

班級排名介於百分之十至百分之二十者，減免半額之學費及雜費。

During the period between the second to fourth year of the bachelor program, students who ranked top 10% of their class in the previous semester will receive full tuition and miscellaneous fee waivers. Students who rank between top 10% to 20% of their class will receive a 50% off on their tuition and miscellaneous fee.

An official bank statement (in either Chinese or English) that indicates an account balance of over USD\$3,000 is required. If a proof of fully funded scholarship or grant provided by government, loan proof of bank or private organization, the amount has to enable the student to cover all expenses in Taiwan.

Note 1: If financial support is not of one's own, it must come with a kinship certificate.

Note 2: If the bank statement is not in US dollars, applicants shall do the conversion and note the exchange rate.

Note 3: The amount entailed the provision of funds is USD\$3,000 or more to cover various expenses, such as books, accommodation, insurance, and living expenses during the first year of enrollment.

- (一)、申請人依個人志願僅填寫一個志願學系。
Applicants can select ONLY one department of their own choices.
- (二)、本校國際專修部學生之入學申請，由各系（所）依其訂定之入學標準進行初審，招生委員會就初審通過名冊予以複審，審查合格錄取之外國新生名冊報請校長核定後，由國際暨兩岸事務處發給錄取生錄取通知。
The applications of international students will be first evaluated by each corresponding department according to its own admission criteria. A preliminary admission roster will be compiled and submitted to the Admission Committee board for further review. A final admission roster will be submitted to the principal for approval. An admission notice will send to each student by the Office of International and Cross-Strait Affairs individually.
- (三)、錄取生收到錄取通知後，應於規定時間內回覆國際暨兩岸事務處入學本校之意願。

Applicants who received the Admission Letter should response to the Office of International and Cross-Strait Affairs by deadline.

- (四)、本校確認錄取生有入學意願後，入學許可即由國際暨兩岸事務處將入學許可以電子郵件方式寄送給每位新生。

Once the enrollment is confirmed, an admission permission certificate will be sent to every new student by e-mail.

- (五)、國際專修部學生入學申請之結果，原則於本校國際暨兩岸事務處受理申請後 10 個工作天內通知申請人（假日順延）；申請人如於交件 20 個工作天後，未接獲本校通知者，請逕洽本校國際暨兩岸事務處查詢。

Application shall be processed within 10 business days, once the application has received. If applicants receive no response from the school after 20 business days, please do not hesitate to contact us immediately.

- (六)、外國學生註冊時，新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險，在校生應檢附我國全民健康保險等相關保險證明文件。前項保險證明如為國外所核發者，應經駐外館處驗證。

International students should take out their own health insurance for the first six months of their arrivals in Taiwan until they are eligible for the National Health Insurance program. Overseas insurance should be verified by an overseas consulate of the Republic of China (Taiwan) in the country of origin.

壹拾、報到與註冊入學/ Registration and Admission

- (一)、國際專修部學生接到入學許可後，應依規定程序辦理報到及註冊手續，逾期未辦理報到者，即以自動放棄入學資格論，但事前以書面提出延期申請並經許可者，不在此限。Once students receive the admission permission certificate, enrollment procedures should be taken following the provisions. Students who fail to enroll on time will be deemed to forfeit their rights of admission, except a written petition is submitted for extension approval.

- (二)、國際專修部學生經入學後，如發現有申請文件資格不符、偽造、假借、塗改等情事，一經查明即開除學籍，亦不發給任何學歷證件；如於畢業後始發覺者，除勒令繳銷其畢業證書外，並公告取消其畢業資格。

Admission shall be denied and/or the student shall be dismissed from Fooyin University after admission if there are any violations of the general academic honor codes and/ or in the authenticity of the applicant's documents. Those who have graduated shall have their diploma revoked.

- (三)、國際專修部學生來臺註冊後，需配合參加本校新生體檢。

The admission permission certificate does not guarantee visa issuance. Visas need to be approved by the Ministry of Foreign Affairs. (Please visit the Bureau of Consular Affairs, Ministry of Foreign Affairs, R.O.C at <https://www.boca.gov.tw/cp-9-185-35222-1.html>)

- (二)、輔英科技大學並未委託或授權其他單位或個人處理招生相關業務或收取任何費用。
Fooyin University has not authorized or collaborated with any unit or individual for international student recruitment or fee collection.
- (三)、凡曾遭國內大專校院退學者或觸犯刑法者，不得再向本校申請入學。入學後經查證屬實者，撤銷其入學資格。
Those who have been expelled or withdrawn from any university or college in Taiwan due to their misconduct, failure of their academic grade, or found guilty of criminal cases are NOT eligible to apply for admission. Applicants who violate this regulation will have their admission nullified, or therefore status as a Fooyin University student will be revoked.
- (四)、申請居留簽證時需繳驗最近3個月內由衛生福利部指定外籍人士體檢國內醫院或國外醫院出具之健康檢查合格證明(居留或定居健康檢查項目表)，國外健檢證明須經中華民國駐外館處驗證。
The applicant needs to submit the health exam certificate when applying for a residence visa. It contains the residence or settlement health examination checklist issued by a domestic or foreign hospital certified by the Ministry of Health and Welfare within 3 months. The health certificate issued by foreign hospital must be verified by Taiwan overseas representative office.
- (五)、本校依據「個人資料保護法」之規定，得於業務範圍內收集、處理並使用於法定範圍內之個人項目，以利招生及註冊等程序之進行。
All personal information collected by Fooyin University during the recruiting and registration process is authorized and protected by the provisions of the Personal Information Protection Act.

1. 依教育部辦法規範申請來臺就讀國際專修部，以一次為限。於完成申請就學學校學程後，除申請碩士班以上學程，得逕依各校規定辦理外，如繼續在臺就學者，其入學方式應與我國內一般學生相同。
Application for studying in Taiwan is based on terms and regulations from Ministry of Education, limited to one-time only. After submitting application (except for master degrees or above), please follow regulations from each school. Also admission process should be exactly the same as local Taiwanese students.
2. 學生成績分學業、操行兩種，以一百分為滿分、六十分為及格，成績不及格或不通過之科目，不給予學分。
Grades will be measured by academic and conduct, 100 as full score and 60 below as fail. Credits will not be given for subjects failed.
3. 大學部修業年限為 6 年，若未在修業年限內完成者，以退學論。
Maximum study period is 6 years for undergraduate, and 4 years for master degree. Students will be dropped out if unable to complete the degree within limited years.
4. 學生需於學校規定時間內繳交學雜費與其他費用，若未依規定時間繳交者，將依逾期未註冊理由，處以退學。
Tuition and other fees must be paid during the semester. Students will be dropped out if unable to pay in time.
5. 因學生使用學生簽證入學，若有休學、退學，必需於 10 天內離境。被退學之學生，將失去申請台灣各大學學士以下級別之使用外國學生身分入學之資格。若休學後復學，需重新辦理居留簽證與換發居留證。
Students must leave Taiwan within 10 days after drop-out of school or dismissal by oneself. For dismissal students who will not be able to apply for any undergraduate (or below) degree in Taiwan as an international student. For reinstatements after approval to leave, students must re-apply and renew their Alien Residence Certificate.
6. 請假:需提前完成學校的線上程序，如無特殊事由且未完成者以曠課論。
Take a leave: Students must complete on-line procedures in advance, otherwise will be considered as absence.
7. 學生於考試時如有作弊行為，一經查出，除該次成績以零分計算外，並視情節輕重分別予以記過、勒令退學或開除學籍之處分。
If cheating is found during a test, the grade will be counted as 0. Also, students may get demerited or even drop out and expelled, depending on the situation.
8. 學生入學後可申請工作證，無校外工作證或違反政府規定工讀時數(學期間工讀時數每週最多 20 小時)，經學校或任何單位查獲者，將有罰款並有立即遣返回國之可能性。
Students can apply for a work permit after enrollment. Without valid working permit or any students who against working hours regulation (maximum 20 hours per week during semester), the student may be fined or even be expelled/deported back to one's country of origin.
9. 依教育部規範，學生須於一年級第二學期結束前通過華語文能力測驗(TOCFL) A2(含)以上，

如未通過華語文能力 A2 級(含)以上測驗者，則本校將逕予退學。

According to the regulations of the Ministry of Education, students must pass TOCFL Level 2 (A2) before the end of the second semester of the first year. If students fail to achieve a level of A2 or higher on the TOCFL, they will be dismissed from school without exception.

10. 正式修讀學士班課程一年後，方得於至製造業、營造業、農業及長期照顧等相關系所申請轉系或轉學。

After the completion of their freshman years, applicants may apply to transfer to departments belong to one of following fields, such as manufacturing industry, construction industry, agriculture, or long-term care.

11. 學校校區內一律禁菸禁酒。違規者並依學校規定辦理。(依政府禁菸防治法規定違規者得罰鍰新台幣 2,000 - 50,000 元)

Smoking and any alcoholic practices are strictly prohibited inside the campus. Anyone who violates the rules intentionally will be fined between NTD\$2,000 and NTD\$50,000.
