壹、申請資格/Applicants' Qualifications

一、入學身分/ Identity

具新南向國家國籍且未曾具有中華民國國籍,於申請時並不具僑生資格者。

An individual of the nationality of new southbound policy (NSP) countries, who has never held nationality status from the Republic of China (R.O.C.) and who does not possess an overseas Chinese student status at the time of their application.

※有下列各款情形之一者,屬中華民國國籍:

- 1、出生時父或母為中華民國國民。
- 2、出生於父或母死亡後,其父或母死亡時為中華民國國民。
- 3、出生於中華民國領域內,父母均無可考,或均無國籍者。
- 4、歸化者。

前項第一款及第二款之規定,於國籍法修正公布時之未成年人,亦適用之。

- *An applicant shall have the nationality of the R.O.C. under any of the conditions provided by the following Subparagraphs:
- 1 · His/her father or mother was a national of the R.O.C. when he/she was born.
- 2 He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the R.O.C. at the time of death.
- 3 · He/she was born in the territory of the R.O.C., and his/her parents can't be ascertained or both were stateless persons.
- 4 · He/she has undergone the naturalization process of R.O.C..

The provisions specified in subparagraphs 1 and 2 above shall also apply to minors at the time of the amendment and promulgation of the Nationality Act.

Preceding Subparagraph 1 and Subparagraph 2 shall also apply to the persons who were minors at the time of the amendment and promulgation of this Act.

二、學歷資格/ Academic Qualification Requirements

(一)申請本專班者需具國外高中畢業或以上學歷,畢業證書須經我國外館認證。

Applicants for this program should have at least high school degrees. The graduation certificate must be certified by the Taiwan's overseas representative offices.

(二)申請人畢業學校須為我國教育部認可或當地國政府權責機關或專業評鑑團體認可, 符合教育部「大學辦理國外學歷採認辦法」規定之學校或我國政府立案之學校。

Applicants must have graduated from schools accredited by the Ministry of Education of the R.O.C. or recognized by local government agencies or professional evaluation organizations, per the 'Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education'.

三、語言能力/Language Proficiency

本校教學以華語授課為主,部分課程採英語授課。申請者需檢附華語文能力證明,符合下列之一:

Classes are instructed mainly in Chinese and partially in English. Applicants should provide either one of the following Chinese proficiency documents:

(一)TOCFL 入門級: A1(含)以上。

TOCFL Test: Level A1 (or above).

(二)HSK:三級(含)以上。

HSK: Level 3 (or above).

(三)修習華語文課程240小時(含)以上。

A proof of 240 hours or more in accumulation of Chinese learning.

★依教育部規範,學生須於一年級第二學期結束前通過華語文能力測驗(TOCFL) A2(含) 以上,如未通過華語文能力 A2 級(含)以上測驗者,則本校將逕予退學。

According to the regulations of the Ministry of Education, students must pass at least TOCFL Level 2 (A2) before the end of the second semester of the first year. If students fail to achieve a level of A2 or above on the TOCFL, they will be dismissed from school without exception.

四、學業成績規定/Academic Performance Requirement

本專班招收學生之學業成績規定為畢業平均成績達 6 以上(滿分 10 分)。

The requirement for admission to this program is a minimum graduation GPA of 6 (out of 10).

最近三個月內經由金融機構提出之中文或英文存款證明新臺幣 30,000 元以上(約美金1,000元),本專班學生第一學期享有學雜費與住宿費全免之全額獎學金及每月生活津貼; 第二至第四學期則需符合一定條件後,方可續領相同獎學金,及每月生活津貼或實習津 貼。

An official bank statement (in Chinese or English) that indicates an account balance of over NTD 30,000 (approximate USD 1,000). The statement must be issued by a financial institution within 3 months prior to application. Students in this program get a full scholarship that covers all tuition and accommodation fees for the first semester, along with a monthly living allowance. From the second to fourth semesters, students need to meet certain conditions to continue receiving the same scholarship, and monthly allowance or an internship stipend.

Note 1: Non-personal financial resources must be accompanied by a kinship certificate.

Note 2: If the currency of the bank statement is neither NT dollars nor US dollars, applicants themselves shall do the conversion and write down the exchange rate.

All applied materials are for school admissions use only, and in addition to providing the individual applicant, admission units, the application program, National Immigration Agency, the Ministry of Education, and the units of academic credential examination, but all the other uses have to be in accordance with the Taiwan "Personal data Protection Act".

Additionally, students must not have any major rule violations and unpaid tuition fees. 書卷獎為前一學期總成績第 1 至 3 名學生,第一名獎學金 3,000 元;第二名獎學金 1,000 元。 The Academic Excellence Award is given to the top three students based on their overall academic performance in the previous semester. The first-place winner receives a scholarship of NTD 3,000, the second-place winner receives NTD 2,000, and the third- place winner receives NTD 1,000.

二、生活津貼 Living Allowance Scholarship

衛福部和合作企業提供生活津貼方式與資格

Methods and Qualifications for Living Allowance Provided by The Ministry of Health and Welfare and Internship Companies

衛福部和合作企業提供專班學生就學期間第一至第三學期每人每個學期 <u>50,000</u> 元 生活津貼;第四學期實習期間則提供實習崗位與實習津貼(至少應比照台灣最低基本薪資)。

The Ministry of Health and Welfare, in cooperation with internship companies, provides per semester living allowance of NTD 50,000 per student from the 1st semester to the 3rd semester. During the 4th semester of internship, the enterprise offers internship opportunities along with an allowance that is no less than the minimal wage (NTD 27,470 per month) in Taiwan.

領取生活津貼學生畢業後即具有留臺就業義務,提供獎助津貼之企業具有優先留用聘僱學生的權利。

After graduation, students are obligated to seek employment in Taiwan. Industries that provide subsidies have the right to prioritize the employment of these students.

三、畢業後履行就業義務 Employment Obligation after Graduation

本專班學生就學期間領取政府及企業獎助,畢業後即具有一定期間的留臺就業義務(不得外派至海外)。學生如中途退出專班或畢業後未履約就業者,所受領之獎助金及生活津 貼必須依規定之原則繳還。原則如下:

Students in this program receive government and corporate assistance during their study period. After graduation, they are obligated to work in Taiwan for a specified period (without being dispatched overseas). If a student withdraws from the program midway or fails to fulfill the employment obligation after graduation, they must repay the received grants and living allowances according to the specified principles. The principles are as follows:

(一)屬不可歸責於學生之原因,無須繳還獎助金及生活津貼:

If the circumstances are not under student control, there is no requirement for repayment:

- 原合作企業因營運調整,於學生在學期間停止提供生活津貼,又學生經學校媒合仍無法覓得其他企業願意續予補助生活津貼,致學生中途退出專班者。
 - Due to the operational adjustment, the original collaborating industry ceases to provide living allowance to student during their learning and student is unable to achieve additional support from other industry, leading the student's withdrawal from the INTENSE program.
- 2. 原合作企業因營運調整,於學生畢業時無職缺可聘用,又學生經學校進行就業輔導及媒合其他企業仍無法覓得適合企業聘僱者。
 - Due to the operational adjustment, the original collaborating company has no job vacancies available for employment upon the student's graduation and, and despite the school's efforts in providing career guidance and facilitating job placement, the student is unable to secure suitable employment opportunities.
- 3.合作企業於學生就業期間有勞動基準法第十四條第一項規定情形,致學生提出終止契約,又學生經學校進行就業輔導及媒合,仍無法覓得適合企業接續聘僱者。 If the collaborating company, during the student's employment period, encounters situations as specified in Article 14, Paragraph 1 of the Labor Standards Act, leading the student to terminate the contract, and despite the school's efforts in providing career guidance and facilitating job placement, the student is still unable to find a suitable company for subsequent employment.

4.學生死亡、因重大疾病或意外事故不能繼續就學或就業,經衛生福利部新制醫院 評鑑合格之教學醫院以上層級,開立認定無法繼續就學或就業證明者,或因事故 致家庭巨變無法繼續就學或就業,經學校查證屬實者。

Student's death, severe illness, or an unforeseen accident preventing them from continuing their studies or employment, a certified document issued by a teaching hospital rated at or above the level of accreditation by the Ministry of Health and Welfare, stating the student's inability to continue education or employment, or in cases where significant family upheaval due to an accident prevents the student from pursuing education or employment, as verified by the school.

(二)屬可歸責於學生之原因,應繳還獎助金及生活津貼:

If the circumstances are under student control, requirement for repayment:

1. 就學期間因個人因素中途退出專班:如申請轉學、轉系、休學返國,經學校輔導後 仍放棄繼續就讀專班、或經學校依學則退學、開除學籍等情形。

Withdrawal from the specialized program during the academic period due to personal reasons such as applying for transfer, changing majors, absence, or returning to one's home country. Even after guidance provided by the school, if the student chooses to leave the specialized program or if the school, in accordance with its regulations, initiates withdrawal or expulsion.

學生學習表現不佳,未通過學校及企業評核標準,並經學校輔導後仍無改善且依學則處以退學、開除學籍等情形。

Poor academic performance, failure to meet the evaluation standards set by both the school and the collaborating industry. Even after school guidance, student fails improve, and in accordance with the school regulations, the student faces withdrawal or expulsion.

3.學生畢業後選擇不至合作企業或相關產業領域就業,或就業後違反公司規定被依 法終止勞動契約,並經學校輔導後仍無改善者。

After graduation, student chooses not to pursue employment with the collaborating industry or in the relevant industrial field, or if, after employment, the student violates company regulations leading to lawful termination of the labor contract, and after school guidance, no improvement is observed.

4. 學生於合作企業就業期間未滿受領獎助金年限:應依其未就業之月數比例繳還產 學獎助金;不滿一月者,以一月計。

If a student, during the employment period with the collaborating industry, does not complete the specified duration for receiving scholarship, repayment should be made based on the proportion of the remaining months unemployed; for periods less than one month, one month's repayment is required.

一、本校外國學生之入學申請,由各系(所)依其訂定之入學標準進行初審,招生委員會就初審通過名冊予以複審,審查合格錄取之外國新生名冊報請校長核定後,由國際暨兩岸事務處發給錄取生錄取通知。

The admission of international students will first be evaluated by each corresponding department according to their own admission criteria. A preliminary admission list will be compiled and submitted to the Admission Committee for further review. A final admission roster will be submitted to the principal for approval. An Admission Letter will then be sent to each admitted student by the Office of International and Cross-Strait Affairs.

二、錄取生收到錄取通知後,應於規定時間內回覆國際暨兩岸事務處入學本校之意願。

Applicants who received the Admission Letter should confirm his/her enrollment to the Office of International and Cross-Strait Affairs before the deadline stated.

三、本校確認錄取生有入學意願後,即由國際暨兩岸事務處將入學許可以電子郵件方式及 紙本方式寄送給新生。

Once the enrollment is confirmed, Admission Certificate will be sent to all admitted new students by e-mail and hard copy.

四、外國學生入學申請之結果,原則於本校國際暨兩岸事務處受理申請後 10 個工作天內通知申請人(假日順延);申請人如於交件 20 個工作天後,未接獲本校通知者,請逕洽本校國際暨兩岸事務處查詢。

Application should be processed within 10 working days starting from the day the application is received. If applicants receive no messages from the school after 20 working days, please do not hesitate to contact us immediately.

捌、報到與註冊入學/Registration and Admission

一、外國學生接到入學許可後,應依規定程序辦理報到及註冊手續,逾期未辦理報到者,即 以自動放棄入學資格論,但事前以書面提出延期申請並經許可者,不在此限。

Once students receive the Admission Certificate, enrollment procedures should be taken following the provisions of the procedure. Students who fail to enroll on time will be deemed to forfeit their rights of admission, except a written petition is submitted for extension approval.

二、外國學生經入學後,如發現有申請文件資格不符、偽造、假借、塗改等情事,一經查明 即開除學籍,亦不發給任何學歷證件;如於畢業後始發覺者,除勒令繳銷其畢業證書外, 並公告取消其畢業資格。

Admission shall be denied and/or the student shall be dismissed from Fooyin University after admission if there are any violations of the general academic honor codes and/ or in the authenticity of the applicant's documents. Those who have graduated shall have their diploma revoked.

三、外國學生接獲本校入學許可後,須提出接獲錄取通知後3個月內之健康檢查記錄。

Upon receiving Admission Certificate, all students need to provide a Health Examination Form with certificate dated within the past 3 months.

四、外國學生來臺註冊後,仍需配合參加本校新生體檢。

Each student also needs to have a physical examination in school after registration.

五、新南向專班學生在學期間二年皆依規定住校;第二學期起若有特殊情況,提出申請並通 過審核得免住宿。

Students in the program are required to reside in on-campus dormitories for the entire two-year study period; however, starting from the second semester, those with special circumstances may apply for exemption from this requirement, which may be granted upon approval.

Application for studying in Taiwan is based on terms and regulations from Ministry of Education, limited to one-time only. After submitting application (except for master degrees or above), please follow regulations from each school. Also admission process should be exactly the same as local Taiwanese students.

Grades will be measured by academic and conduct, 100 as full score and 60 below as fail. Credits will not be given for subjects failed.
