## 壹、申請資格/ Applicants' Qualifications

### 一、入學身分(含轉學生)/ Identity( Transferred students are included)

符合以下身分者，得以外國學生身分申請入學。

International students who held one of the following identities may apply for the admission.

(一) 具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依規定申請入學。

An applicant of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:

1、未曾以僑生身分在臺就學。

An applicant has never undertaken studies in Taiwan as an overseas Chinese student.

2、未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

An applicant has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

※有下列各款情形之一者，屬中華民國國籍：

1、出生時父或母為中華民國國民。

2、出生於父或母死亡後，其父或母死亡時為中華民國國民。

3、出生於中華民國領域內，父母均無可考，或均無國籍者。

4、歸化者。

前項第一款及第二款之規定，於國籍法中華民國八十九年二月九日修正施行時未滿二十歲之人，亦適用之。

※An applicant shall have the nationality of the R.O.C. under any of the conditions provided by the following Subparagraphs:

1、His/her father or mother was a national of the R.O.C. when he/she was born.

2、He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the R.O.C. at the time of death.

3、He/she was born in the territory of the R.O.C., and his/her parents can't be ascertained, or both were stateless persons.

4、He/she has undergone the naturalization process.

The provisions of Subparagraphs 1 and 2 of the preceding Paragraph shall also apply to those under the age of 20 at the time of the amendment and implementation of this Act on February 9, 2000.

(二) 具外國國籍並符合下列規定，且最近連續居留海外六年以上者，得依本規定申請入學（計算至 2025 年 8 月 1 日止且每年在臺停留時間不超過 120 日）：

An applicant of foreign nationality who meets the following requirements and

who in the immediate past has resided overseas continuously for at least six years is permitted to apply for admission to an educational institution, in accordance with these Regulations.

1、申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An applicant who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.

2、申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An applicant who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application. (As determined by the Ministry of Interior up to August 1, 2025)

3、前二款均應符合前項第一款及第二款規定。

An applicant referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前列規定之限制。

前列所定六年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval. The six years as prescribed in the first paragraph shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

(三) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations.

(四) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations.

(五) 本簡章所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間不得逾一百二十日。連續居留海

外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term “overseas” used in this admission brochure refers to countries or regions other than the Mainland Area, Hong Kong, and Macao; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

1、就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education.

2、就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

Spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas.

3、交換學生，其交換期間合計未滿二年。

Spent a total period of less than two years in Taiwan as an exchange student.

4、經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

Spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.

具外國國籍並兼具中華民國國籍，且於外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受前述規定之限制。

A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to these Regulations may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the above restrictions.

All required documents and regulations of application are based on MOE “Regulations Regarding International Students Undertaking Studies in Taiwan”. ## 二、學歷資格/ Academic Qualification Requirements

- (一)外國學生具以下學歷資格者得申請入學本校日間部碩士及學士學位課程。  
申請人的學歷及相關學歷證明文件應經臺灣駐外代表處或入學申請授權的機構驗證。

International students with corresponding academic qualification are eligible for master or bachelor programs in Day Division. Qualification documents for application should be verified by Taiwan's overseas representative offices or authorized agencies.

- 1、具有等同國內大學院校學歷者，可申請碩士班。

Graduate School (Master) Program: Applicants should be graduated from a public, private, or foreign universities, colleges or equivalent.

- 2、具有等同國內專科學歷者，可申請二年制學士班。

Two-Year Bachelor Program: Applicants should be graduated from a public, private, or foreign junior college or equivalent.

- 3、具有等同國內高中職學歷者，可申請四年制學士班。

Four-Year Bachelor Program: Applicants should be graduated from a public, private, or foreign high school or equivalent.

- 4、具有等同國內國中學歷者，可申請五年制副學士班。

Five-Year Associate degree Program: Applicants should be graduated from a public, private, or foreign junior high school or equivalent.

- (二) 以上外國學生最高學歷必須符合本國「入學大學同等學力認定標準」相關規定（請參見教育部

<https://law.moj.gov.tw/ENG/LawClass/LawAll.aspx?pcode=H0030032>）。畢業年級相當於國內高級中等學校二年級之國外或香港、澳門同級同類學校畢業生(如英制中學五年或十一級)，得申請本校學士班。除原課程外，另需增修至少 12 個畢業學分，其外加科目由各系另行訂定之。畢業 2 年(含)以上者，逕以高中同等學力採認之，不另增修畢業學分。

The recognition of the highest educational qualification of applicant shall be in accordance with the Standards for Recognition of Equivalent Qualifications for University Entrance Examination (see the Ministry of Education, R.O.C at (<https://law.moj.gov.tw/ENG/LawClass/LawAll.aspx?pcode=H0030032>)).

Applicants, having completed study at an equivalent foreign or Hong Kong/Macao high school (Form 5 or Year 11), equivalent to 2<sup>nd</sup> year of senior high school in Taiwan, may apply for an undergraduate program with a condition of taking extra 12 credits beside graduation credit criteria and courses designated by intended departments. Applicants having graduated from senior high school for no less than 2 years are considered as senior high school graduates with equivalent certificate, exempt from the required condition.

### 三、語言能力/ Language Proficiency

Classes will be instructed mainly in Chinese. Applicants should provide one of the following Chinese proficiency documents:

(一) TOCFL 基礎級：A2(含)以上

TOCFL Test : Level A2 (or above)

(二) HSK：四級(含)以上

HSK : Level 4 (or above)

Note: Regulations Regarding International Students Undertaking Studies in Taiwan Article 11: An international student who reports to register at a university before it is already one-third of the way into the first semester of the current academic year shall be registered for the first semester.



## 參、申請應繳交資料/ Required Documents

### 一、入學申請表/ Application Form

### 二、護照影本或其他國籍證明文件

One copy of passport or other equivalent verification of nationality.

### 三、經我國駐外使領館、代表處、辦事處或其他經外交部授權機構驗證之外國學校最高學歷或同等學力證明文件及成績單（中、英文以外之語文，應附中文或英文譯本）。

One copy of the highest academic diploma and the transcript of the highest educational degree authenticated by Taiwan, R.O.C. embassies, representative, consulates, or other mission authorized by the Taiwan Ministry of Foreign Affairs. (If the original document is not in English or Chinese, the document must be notarized after being translated into English or Chinese).

### 四、財力證明或全額獎學金證明文件

An official bank financial statement and/ or proof of full scholarship award document  
最近三個月內經由金融機構提出之中文或英文存款證明新臺幣 120,000 元以上（約美金 4,000 元）或政府、大專校院或民間機構提供全額獎助學金之證明文件。

註 1：非本人之財力須另繳附親屬關係證明。

註 2：若存款證明之幣值非新臺幣或美金，申請人需自行註明匯率並換算成相當於新臺幣或美金之金額，註記於存款證明上。

An official bank statement (in Chinese or English) that indicates a minimal account balance of NTD 120,000 (approximate USD 4,000). The statement must be issued by a financial institution within 3 months prior to application, OR proof of full scholarship or grant provided by any government, university/college, or institution.

Note 1: Non-personal financial resources must be accompanied by a kinship certificate.

Note 2: If the currency of the bank statement is neither NT dollars nor US dollars, applicants shall do the conversion and write down the exchange rate by themselves.

### 五、入學申請切結書/ Affidavit letter

Students are required to fill out the Eligibility Declaration form and sign it personally.

### 六、自傳及留學計畫書(需明確說明來輔英就讀動機)

Autobiography and study plan in Chinese or English. (Need to clearly explain your motivation for studying at Fooyin University)

### 七、語言能力證明/ Language Proficiency in Chinese language

本校教學以華語授課為主。申請者需檢附華語文能力證明，符合下列之一：

Classes will be instructed mainly in Chinese. Applicants should attach either one of the following Chinese proficiency documents:

1.TOCFL 基礎級：A2(含)以上/ TOCFL Test：Level A2 (or above)

2.HSK：四級(含)以上/ HSK：Level 4 (or above)

### 八、其他有助審查之文件（如英文能力證明、證照、獎狀、推薦信…等）

Other supportive documents. (For example: English language proficiency, certificates of examinations, awards, recommendation letters etc.).

- 九、申請人於報名時所提供之資料，僅作為本校招生使用，且除提供申請人個人、本校招生相關單位、申請系所、移民署、教育部及其委託之學歷查證單位使用外，其餘均依照「個人資料保護法」相關規定處理。

All applied materials are for school admissions use only, and in addition to providing the individual applicant, admission units, the application program, National Immigration Agency, the Ministry of Education, and the units of academic credential examination, but all the other uses have to be in accordance with the Taiwan "Personal data Protection Act".

## 肆、其他申請注意事項/ Related Information

- 一、申請人至多可同時申請三個系所並填寫志願序。

Applicants can apply for a maximum of three departmental programs at the same time. Please specify your priority in order.

- 二、申請人不曾以僑生身分在中華民國就學。

Applicants have never studied in the Republic of China with Overseas Chinese student identities.

- 三、報名時所繳之外國學校最高學歷或同等學力證明文件，其為外國學校核發者，除海外臺灣學校所發者外，應依「大學辦理國外學歷採認辦法」相關規定辦理。

The diploma and transcript issued by foreign educational institute authenticated and comply with “ Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education”, except for diplomas and transcripts issued by Overseas Taiwanese schools.

- 四、凡曾遭國內大專校院退學者或觸犯刑法者，不得再向本校申請入學。入學後經查證屬實者，撤銷其入學資格。

Those who have been expelled from any university or college in Taiwan due to their misconducts, failure of their academic grade, or found guilty of criminal cases are NOT eligible to apply for admission. Applicants who violate this regulation will have their admission nullified, therefore, their status as a Fooyin University student will be revoked.

- 五、錄取者應於註冊時繳交我國駐外使領館、代表處、辦事處或其他經外交部授權機構驗證之外國學校最高學歷或同等學力證明文件之正本(中、英文以外之語文，應附中文或英文譯本)。

All admitted students should submit the original copy of the highest academic diploma authenticated by Taiwan, R.O.C. embassies, representative, consulates, or other mission authorized by the Taiwan Ministry of Foreign Affairs at the time of registration. (If the original document is not in English or Chinese, the document must be notarized after being translated into English or Chinese).

- 六、如有其他未盡事宜，悉依教育部「外國學生來臺就學辦法」、「輔英科技大學學生學籍規則」暨相關規定辦理。

For all other related information, please refer to “MOE Regulations regarding International Student Studies in Taiwan”, the “International Student Recruiting Policy of Fooyin University”, and other related guidelines.

According to Fooyin University Scholarships Guidelines for Excellent Foreign Students, if students reserve their admissions status or withdrawal before registration, their scholarships shall be revoked.

## 捌、審查及錄取通知/ Review and Notification for Admission

- 一、本校外國學生之入學申請，由各系（組）進行申請案審查，招生委員會訂定各系（組）最低錄取標準，以總成績排序達最低錄取標準者，於招生名額內為正取生，餘為備取生。未達最低錄取標準，雖有名額不予錄取。外國學生錄取名單經招生委員會確認後正式公告，由本校發給入學通知。

The admission application of foreign students of our school is reviewed by each department (group). The Admissions Committee sets the minimum admission standard for each department (group). Those who meet the minimum admission standard in terms of total score ranking will be admitted within the enrollment quota, and the rest will be reserved. If the minimum admission standard is not met, no admission will be given even if there are vacancies. The list of admitted foreign students will be officially announced after confirmation by the Admissions Committee, and the school will send admission notices.

- 二、錄取生收到錄取通知後，應於規定時間內回覆國際暨兩岸事務處入學本校之意願。

Applicants who received the admission certificate should confirm his/her enrollment to the Office of International and Cross-Strait Affairs before deadline.

- 三、本校確認錄取生有入學意願後，即由國際暨兩岸事務處將入學許可電子郵件方式及紙本方式寄送給新生。

Once the enrollment is confirmed, admission certificate will be sent to all new students through e-mail and mail.

- 四、外國學生入學申請之結果，原則於本校國際暨兩岸事務處受理申請後 10 個工作天內通知申請人（假日順延）；申請人如於交件 20 個工作天後，未接獲本校通知者，請逕洽本校國際暨兩岸事務處查詢。

Application should be processed within 10 working days starting from the day the application is received. If applicants receive no messages from the school after 20 working days, please do not hesitate to contact us immediately.

### Basic dormitory Fee (On-campus Dormitory)

The dormitory fee ranges from NTD 11,000 to NTD 13,500 per semester for 6-bed to 4-bed room respectively. These rooms are equipped with air conditioning, computer tables, furniture, telephone, and free Wi-Fi.
